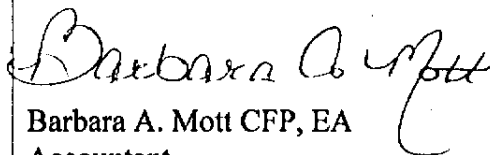
Dear Sir/Madam;

We originally incorporated in February 1990 under the name J J Alternator & Starter, Inc. with federal identification number 65-0175471. We dissolved that corporation and on August 22, 1996 we started a new one under the name J Jenkins Alternator, Inc. with federal identification number 65-0701729.

Our annual report shows the correct ID number; however, it shows our old name. This is not a name change, this is a new company. We are enclosing copies of our Articles of Incorporation along with our notice from the Internal Revenue Service showing our new EIN.
