

As per my conversation with Sean Toner, Administrator, this afternoon, please find enclosed my completed corporate annual report and check for \$165 for 1997. As we discussed on the phone, our office moved following our initial formation as a corporation from 3083 Reo Lane, Lake Worth to 157 Apache Street, Tavernier. We never received the first notice. We did receive the second notice. We immediately began completing that application and noted that we needed to apply for a federal ID number (at that time we did not see that there was a space on the application to mark that it had been applied for). Our application for a federal ID number took several months to process as our accountant initially submitted an "old" application which did not require my social security number, as required. During that time period we received the Notice of Dissolution, and our initial inquiries to your office indicated that we would be required to pay the penalty fees for late filing.

I appreciate Mr. Toner's assistance today in resolving the issue. As he requested, I have also enclosed a check for \$150 for 1998. If you require any further documentation please contact me.
