**ARTICLES OF INCORPORATION
OF

I, the undersigned, for the purposes of forming a corporation under the Florida General Corporation Act, Chapter 607 Florida Statutes, do hereby adopt the following articles of Incorporation:

ARTICLE I

The name of the corporation is:

The duration of the corporation is perpetual.
