# Articles Of Incorporation Of Cornerstone Properties, Inc.

#### Article I - Name

The name of this corporation is Cornerstone Properties, Inc.

## Article II - Effective Date and Duration

This corporation shall begin existence as of August 1, 1996, and continue perpetually unless dissolved.

## Article III - Purpose

This corporation is organized for the purpose of transacting any and lawful business.
