ARTICLES OF INCORPORATION
OF
TRY IT AGAIN, INC.

The undersigned incorporator(s) for the purposes of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

- FIRST: The name of the corporation is TRY IT AGAIN, INC., a Florida Corporation (the "Corporation").
- SECOND: The principal office address and mailing address of the Corporation is: C/O: LAW OFFICES OF STUART R. MORRIS, P.A., 2000 Glades Road, Suite 412, Boca Raton, Florida 33431.
- THIRD: The Corporation is authorized to issue 100,000 shares of common stock, par value \$.01 per share.
