ARTICLES OF INCORPORATION
OF

Article One - Name

The name of this corporation shall be:

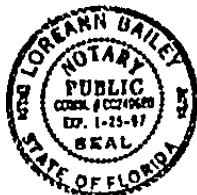




