ARTICLES OF INCORPORATION

of

**Sebastian Distributing, Inc.**

The undersigned, acting as incorporator(s) of a corporation under the Florida Business Corporation Act, adopts the following articles of incorporation for such corporation.

First: The name of the corporation is **Sebastian Distributing, Inc.**

Second: The period of its duration is perpetual.

Third: The purpose or purposes for which the corporation is organized are to transact the business and all other business not forbidden by law.

Fourth: The aggregate number of shares which the corporation shall have authority to issue 1000 shares at one (\$1.00) par value.

Fifth: The address of the initial registered office of the corporation is 2690 Coral Landings Blvd.; Suite 138; Palm Harbor, FL 34684 and the name of the registered agent at such address is Jerome J. Cooley. The principal office of the corporation is 2690 Coral Landings Suite 138; Palm Harbor, FL 34684, the same as the initial registered office.






