ARTICLES OF INCORPORATION
OF
MUSIC WITH A MESSAGE INC.

The undersigned incorporator, competent to contract, heroby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be:

MUSIC WITH A MESSAGE INC.

ARTICLE II. NATURE OF BUSINESS

The nature of business the company will transact will be educational experiences, presentations and lessons of varied disciplines delivered to public and private groups or individuals in public places, private or public schools or colleges or other sites along with doing business incidental to or connected with such work including program design or consultation. Activities may include walking tours, theme or variety entertainment, musical science, musical enhanced cultural lessons and more.

" The foregoing purposes and activities will be interpreted as examples only and not as limitations and nothing shall be deemed as prohibiting the corporation from extending its activities to any related or otherwise permissible lawful business purposes which may be permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 100 shares of common stock having \$1.00 par value per share.

ARTICLE IV. REGISTERED AGENT

ARTICLE V. TERM OF EXISTENCE

This corporation is to exist perpetually.

ARTICLE VI. OFFICERS AND DIRECTORS

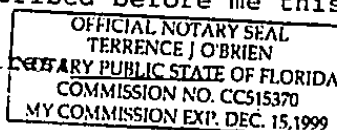
