ARTICLES OF INCORPORATION
OF
CENTRAL FLORIDA VENTURES, INC.

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation shall be:

CENTRAL FLORIDA VENTURES, INC.

ARTICLE II - NATURE OF BUSINESS
