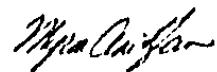

ARTICLES OF INCORPORATION
OF
PRO SPORTS EXPOSE CORP.

ARTICLE I

The name of the corporation is PRO SPORTS EXPOSE CORP. (hereinafter called the "Corporation").

ARTICLE II

The address of the principal office and the mailing address of the Corporation is 10738 Lakehill Drive, Clermont, Florida 34711.

ARTICLE III

The capital stock authorized, the par value thereof, and the characteristics of such stock shall be as follows:

The Corporation shall hold a special meeting of shareholders only:

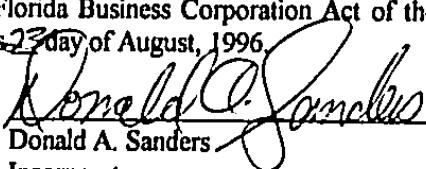
ARTICLE VII
