# ARTICLES OF INCORPORATION OF QUALITEX PRODUCTS, INC.

ARTICLE I <u>NAME</u>

The name of this corporation shall be:

QUALITEX PRODUCTS, INC.

# ARTICLE II DURATION

This corporation shall commence its existence upon the filing of these Articles and the duration of this corporation is perpetual.
