ARTICLES OF INCORPORATION

OF

SPORTSPARK, INC.

The undersigned, for the purposes of forming a corporation, under the FLORIDA BUSINESS ACT, does hereby adopt the following Articles of Incorporation:

ARTICLE I

The name of the corporation is SPORTSPARK, INC. The mailing address of the corporation is 7113 12th Ct. E., Sarasota, Florida 34243. The principal place of business is 7200 Clark Road, Sarasota, Florida 34243.

ARTICLE II

The duration of the corporation is perpetual.

ARTICLE III PURPOSE

The general purposes for which the corporation is organized are the following:
