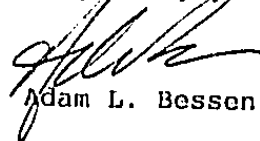

The undersigned does hereby associate himself into a corporation under chapter 607 of the laws of the State of Florida and does hereby certify as follows:

2. The corporation shall have perpetual existence.

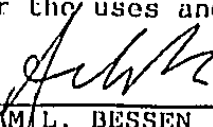

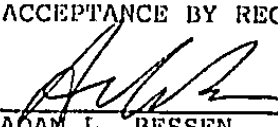

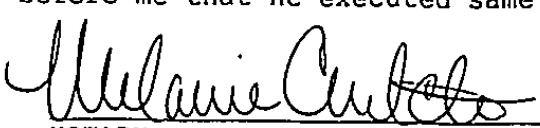
