
ARTICLE VIII



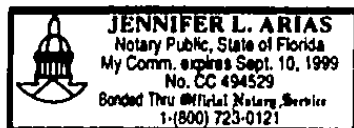


