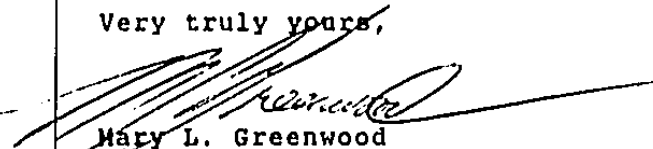

ARTICLES OF INCORPORATION
OF
JPO AIR CONDITIONING & REFRIGERATION, INC.

The undersigned incorporators to these Articles of Incorporation hereby form a corporation (the "Corporation"), under the laws of the State of Florida as follows:

ARTICLE I

Name

The name of the Corporation is JPO AIR CONDITIONING & REFRIGERATION, INC.

ARTICLE II

Term of Existence

The date when corporate existence shall commence shall be the date of the filing of these Articles of Incorporation in the Office of the Florida Department of State, and the Corporation shall have perpetual existence thereafter.

ARTICLE III

Nature of Business

The Corporation is organized to engage in the business of providing air conditioning and refrigeration contracting services, and also to perform any and all other lawful business activities.

ARTICLE IV

Capital Stock

The Corporation is authorized to issue 100 shares of \$1.00 par value common stock, which shall be designated common shares.

ARTICLE V

Corporate Office, Registered Office, and Agent

The principal corporate offices of the Corporation shall be located at 1317 Piney Branch Circle, Valrico, Florida 33594. The initial registered office of the Corporation is also 1317 Piney Branch Circle, Valrico, Florida. The name of the Corporation's initial registered agent at such address is Jack P. Osmanski.

ARTICLE VI

Directors

The Corporation shall have two directors initially. The number of directors may be increased or decreased from time to time by bylaws of the

The power to adopt, alter, amend or repeal Bylaws shall be vested in the Board of Directors of the Corporation.

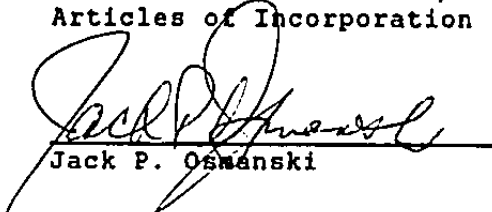
ARTICLE IX

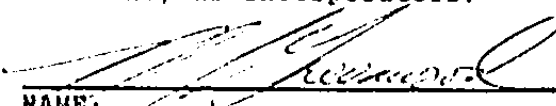
