The name and address of the initial registered agent is JACQUELINE HUTMAN, 10746 N.E. 4th AVENUE, MIAMI, FL 33161.

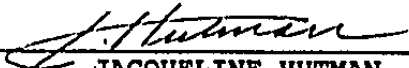
