ARTICLES OF INCORPORATION

OF

- 3. If the contract or transaction is fair and reasonable as to the corporation at the time it is approved by the board, a committee or the shareholders.
 - B. Common or interested directors may be counted in

determining the presence of a quorum at a meeting of the Board of Directors or of a committee which approves such contract or transaction.
