Enclosed please find my 2000 Uniform Business Report and my check in the amount of \$150.

I understand that after May 1, 2000, the amount is supposed to be \$550. I am writing this letter with hopes that you will understand and accept this check because an extreme hardship situation.

I am a one person corporation and it is a very small company, basically doing little or no business at this time. I do all of my bookkeeping and monthly accounting. In March of 2000, my sister-in-law came from Canada to live with us suffering with a fatal and terminal brain cancer, glioblastoma. We were her only care-givers and she took constant care around the clock with this horrible death she suffered. She passed away on May 9, 2000 (death certificate enclosed). (Judith Martin is her name and my husband is James M. Bloodgood)

Due to the extreme hardship and tremendous bereavement by my husband and I, (we also had to make all of the funeral arrangements here as her service was in Jupiter and not in Canada) my mail and bills were put in a pile for later. I have missed many dates for bill paying, etc., and all of the companies have been very understanding. I do hope you will accept this check in good faith and understand our crises. The \$550 is overwhelming, and in that the company makes no money, it is almost impossible to pay, especially after all of the expenses from my sister-in-laws illness and funeral. I keep the corporation going with the hopes that my patented hair accessory will take off someday. I am working on it.

Please, please understand and accept this payment.
