#### ARTICLES OF INCORPORATION

OF

#### ROCKER'S BEACH SHOP, INC.

WE, THE UNDERSIGNED, do hereby associate ourselves together for the purpose of forming a corporation under the laws of the State of Florida, and do hereby certify as follows:

#### ARTICLEI - NAME

The name of the Corporation shall be: ROCKER'S BEACH SHOP, INC., a Florida Corporation.

### ARTICLE II - PURPOSE

- A. To carry on and engage in the Retail Sale of men's and women's swimwear, beachwear, sunglasses, towels and all other articles and accessories which may be related thereto.
- B. To carry on and engage in any business or activity which may be authorized and permitted under and by virtue of the laws of the United States of America or the State of Florida.

#### ARTICLE III- CAPITAL STOCK

The Corporation shall be authorized to issue capital stock in the following manner, to wit:
