NAME

The name of this corporation is: Shedco Enterprises, Inc.

ARTICLE 2

DURATION

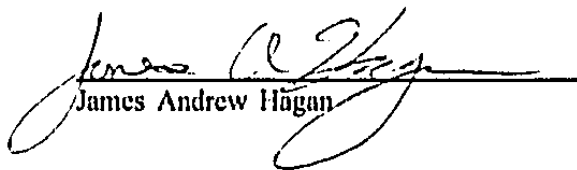

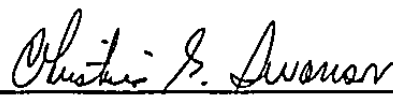

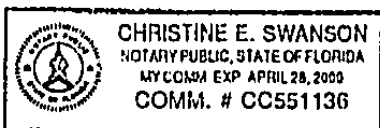
