ARTICLE I - NAME

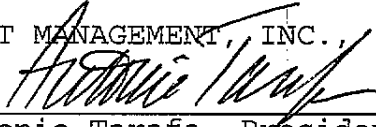
The name of this corporation shall be ATAR MANAGEMENT, INC.

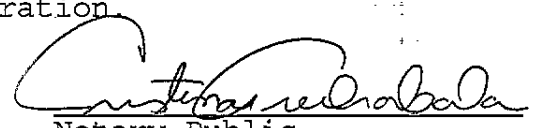
