This Corporation is authorized to issue 1,000 shares of common stock, all of which shall be of the par value of \$.01 per share.

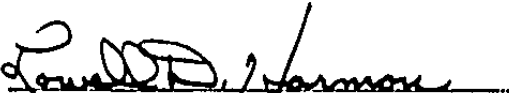

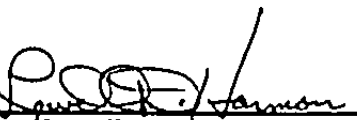
