ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of this Corporation pursuant to Chapter 607 of the Florida Statutes, hereby forms a corporation for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for such Corporation:

ARTICLE I - NAME OF CORPORATION

The name of this Corporation shall be LAND FOODS, INC. and the principal place of business shall be 7307 Grace Road, Orlando, FL 32819.

ARTICLE II - TERM OF EXISTENCE


