ARTICLE I

The name of this corporation shall be ORO MARKETING GROUP, Inc.

ARTICLE II

The principal office and mailing address of this corporation shall be

Tampa, Fl 33629

ARTICLE III

This corporation is formed for the purpose of conducting any business or business transaction lawfully permitted by the Florida Business Corporation Act.

ARTICLE IV

The aggregate number of shares of capital stock authorized to be issued by this corporation shall be 100 shares of common stock, with a par value of \$10.00 per share, the consideration for which may be paid by money, property, or services as may be fixed by the board of directors from time to time.

ARTICLE V

The initial registered office of this corporation shall be located at 3613 El Prado Blvd., Tampa, Florida, 33629, and the initial registered agent of this corporation shall be **Grant D. Whitworth, Esq.**, who is familiar with the obligations of that position and whose signature on these Articles constitutes his acceptance of that appointment. 




