## ARTICLE 1. - NAME

The name of this corporation is Artwork & Photography For Catalogs, Inc.,

# ARTICLE 2. - PRINCIPAL OFFICE: MAILING ADDRESS

The principal office and mailing address of the corporation shall initially be 36 North Sandy Hook Road, Sarasota, FL 34242. The corporation may change its principal office and/or mailing address from time to time as permitted by law.

## **ARTICLE 3. - PURPOSE**

This corporation is organized for the purpose of transacting any and all lawful business.

### ARTICLE 4. - CAPITAL STOCK
