ARTICLES OF INCORPORATION

of

TREASURE COAST MEDIATION, INC.

The undersigned subscriber of these Articles of Incorporation, a natural person to contract, in order to form a corporation under the laws of the State of Florida, certifies the following:

ARTICLE I

NAME OF CORPORATION

The name of this corporation shall be TREASURE COAST MEDIATION, INC.

ARTICLE II

TERM OF EXISTENCE

This corporation shall exist perpetually.

ARTICLE III

NATURE OF BUSINESS
