

The undersigned subscriber of these Articles of Incorporation, a natural person to contract, in order to form a corporation under the laws of the State of Florida, certifies the following:

ARTICLE I

NAME OF CORPORATION

The name of this corporation shall be **TREASURE COAST MEDIATION, INC.**

ARTICLE II

TERM OF EXISTENCE

This corporation shall exist perpetually.

ARTICLE III

NATURE OF BUSINESS

This corporation may engage in any transaction and carry on any lawful business whatsoever, including the providing of services, that may seem to the corporation capable of being carried on or calculated directly or indirectly to promote the interests of the corporation or to enhance the value of its properties; and to have, enjoy and exercise all of the rights, powers and privileges which are now or may hereafter be conferred upon corporations organized under the laws of the State of Florida and the United States of

America.

ARTICLE IV

CORPORATE STOCK

The maximum number of shares of stock that this corporation is authorized to issue at any one time is Two Hundred Thousand (200,000) shares of common stock, each share having the par value of One Dollar (\$1.00) per share. The consideration to be paid for each share shall be fixed from time to time by the Board of Directors.

ARTICLE V

PRINCIPAL OFFICE

The initial street address of the principal office of this corporation is to be 2400 SE Midport Road, Suite 200, Port St. Lucie, Florida 34952. The Board of Directors, from time to time, may move and relocate the principal office to any other address in Florida.

ARTICLE VI

INITIAL REGISTERED AGENT AND OFFICE


