ARTICLES OF INCORPORATION

ARTICLE I NAME

The name of the corporation shall be DYNAMIC CONSTRUCTION SERVICES, INC.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation is 173 Eglin Parkway, N.E., Ft. Walton Beach, Okaloosa County, Florida, 32548.

ARTICLE III CAPITAL STOCK

The number of shares of stock that this corporation is authorized to have outstanding at any one time is Seven Thousand Five Hundred (7,500) shares of One Dollar (\$1.00) par value stock.

ARTICLE IV DURATION

This corporation shall exist perpetually and shall commence corporate existence on the date of the filing of these Articles of Incorporation with the Florida Department of State.

ARTICLE V PURPOSES OF CORPORATION

This corporation is organized for the purpose of general contracting and construction service plus any or all lawful business not inconsistent with the laws of the State of Florida.

ARTICLE_VI PREEMPTIVE_RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class, or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as may nearly be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VII INITIAL REGISTERED AGENT AND OFFICE
