ARTICLE OF INCORPORATION
OF
RADIO EXPORT, INC.

ARTICLE ONE

The name of the corporation is RADIO EXPORT, INC.

ARTICLE TWO

The period of its duration is perpetual.

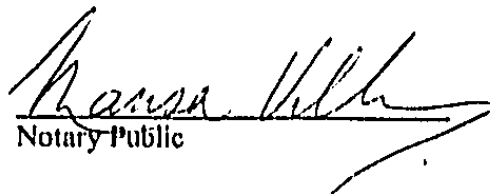
