Articles of Incorporation, as follows:

### ARTICLE 1 - NAME

The name of the corporation shall be: PUPI CONSTRUCTION CO., INC., ARTICLE II - NATURE OF BUSINESS

 The general nature of the business and the objects and purposes proposed to be transacted and carried on, or to do any and all of the things hereinafter mentioned, as fully and to the same extent as natural persons might or could do, viz:

To borrow money and contract debts for the transaction of its business and for the exercise of its corposate rights, privileges or franchises, or for any other tawful purpose of its incorporation; to issue bonds, promissory notes, bills of exchange, debentures and other obligations and evidences of indebtedness payable at a specified time or times or payable upon the happening of a specified event or events, whether acquired by mortgage, pledge or otherwise, or unsecured, for money borrowed or in payment for property purchased or acquired by any other lawful objects.
