The undersigned incorporator hereby makes, subscribes to, acknowledges and files these Articles of Incorporation for the purpose of organizing and incorporating a corporation for profit under the laws of the State of Florida.

ARTICLE I

The name of the corporation shall be:

FLAGLER COUNTY DEVELOPMENT CORPORATION

and shall hereinafter be referred to as the "corporation". The business and mailing address of the corporation shall be 1 Florida Park Drive, Palm Coast, Florida 32137.

ARTICLE II

The time and date on which corporate existence of this corporation shall begin at 12:01 o'clock A.M. effective on 27th of August, 1996, and this corporation shall have a continuous and perpetual existence thereafter.

ARTICLE III
