Pursuant to Chapter 607 of the Florida Business Corporation Act, the undersigned incorporator submits these articles of incorporation for the purpose of forming a for-profit corporation.

Article 1. The name of the Corporation is FRAY Construction Company, Inc.

Article 2. The principal place of business and mailing address of this corporation is 3908 Magnolia Drive, Leesburg, Florida 34748.

Article 3. The corporation is authorized to issue one class of stock, that being 4,000 shares of no par value, common stock, with identical rights and privileges, the transfer of which is restricted according to the bylaws of the corporation.


