**ARTICLE I**

#### **ARTICLE IX** **OFFICERS AND DIRECTORS**



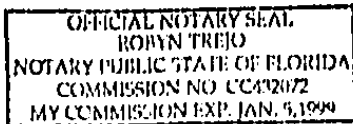
