## ARTICLES OF INCORPORATION

OF

## FLORIDA HIGHWAY PATROL COMMAND OFFICERS ASSOCIATION, INC.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation:

Article I. Name and Address. The name and address of the Corporation is: FLORIDA IIIGIIWAY PATROL COMMAND OFFICERS ASSOCIATION, INC., 5840 North Orange Blosson Trail, #260, Orlande, Florida 32810.

Article 2. Duration. The duration of the Corporation is perpetual.

the following:

Article 3, Purpose. The general purposes for which the Corporation is organized are

 to engage in and transact any lawful business for which corporations may be incorporated under the Florida Business Corporation Act. No other purpose limits this general purpose in any way;

b. to conduct activities for the benefit and welfare of the Members of the Florida Highway Patrol Command Officers Association, Inc.; and

 to do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.

Article 4. Capital Stock. The aggregate number of shares which the Corporation is authorized to issue is Ten Thousand (10,000) shares of common stock. Such shares shall be of a single class and shall have a par value of One Dollar and No Cents (\$1,00) per share.

Article 5. Initial Registered Office and Agent. The street address of the initial registered office of the Corporation is 1200 South Pine Island Road, Plantation, Florida 33224 and the name of its initial Registered Agent at that address is CT Corporation System.

Article 6. Initial Board of Directors. The number of Directors constituting the initial Board of Directors is One (1). The number of Directors may be increased or decreased from time to time in accordance with the Bylaws but shall never be less than one (1). The name and address of each initial Director of the Corporation is as follows:

Article 7. Incorporators. The name and address of each Incorporator is as follows: Captain Kevin Guidry, 5840 North Orange Blossom Trail, #260, Orlando, Florida 32810.

Article 8. Amendment. The Corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation or any amendment to them, and any right conferred upon the Shareholders is subject to this reservation.

Article 9, Indemnification. The Corporation shall indemnify each Officer and Director, including former Officers and Directors, to the full extent permitted by law.

Article 10. Stock Transfer Restrictions. Shares of capital stock of the Corporation field by each Shareholder may not be sold or otherwise transferred to other persons unless first offered to this Corporation. The price, terms and other provisions regarding this restriction may be specified by written agreement among the Shareholders, which agreement may expand this Article and which may also include the Corporation as a party.

Article 11. Bylaws. The power to adopt, alter, amend, and repeal the Bylaws shall be vested in the Board of Directors.
