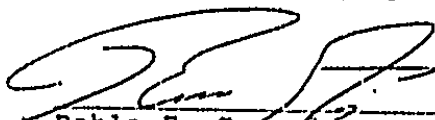

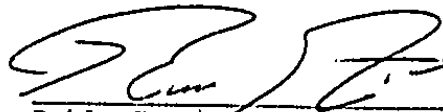
ARTICLE X-EFFECTIVE DATE

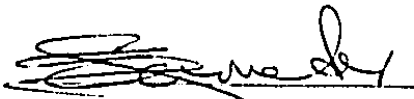
'BEFORE ME, the undersigned authority, this day personally appeared Jennifer G. Corredor, who first by me being duly sworn deposes and says:
