The undersigned, acting as the incorporator of the corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

NAME: The name of the corporation is T.S.A.,-INC. TRUP INC.

ARTICLE II

REGISTERED OFFICE AND REGISTERED AGENT: The street address and telephone number of the initial registered office is 106 ST. GORGE STREET, ST. AUGUSTINE, FLORIDA 32084, (904) 829-8452.2409

The name of the initial registered agent is TRUPTI S. AMIN, who is familiar with the accepts of the duties and responsibilities as Registered Agent for said Corporation.

PRINCIPAL OFFICE AND ADDRESS is the same as the REGISTERED OFFICE.
