in, the undersigned person in horeby prosent in myself for the purpose of forming a corporation under the laws of the State of Florida, and do hereby adopt the following as Articles of incorporation, and make application for charter in accordance with same.

ARTICLES OF INCORPORATION

ARTICLE I.

The name of this corporation shell be:

The general nature of the business to be transacted shall be to engage in any activity or business permitted under the laws of the United States, and the State of Florida.
