We, the undersigned, for the purposes of forming a corporation under the Florida General Corporation Act, Chapter 607 Florida Statutes, do hereby adopt the following articles of incorporation:

ARTICLE I

The name of the corporation is:

The aggregate number of shares of common stock which the

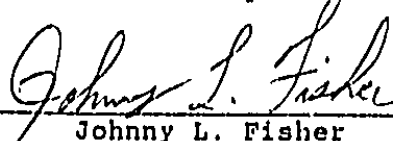
corporation is authorized to issue is ONE HUNDRED (100). Such shares shall be of a single class, and shall be with par value of \$100.
