**ARTICLES OF INCORPORATION
OF
PRESLEY ADJUSTING SERVICES, INC.**

THE UNDERSIGNED, acting as sole incorporator of Presley Adjusting Services, Inc., under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I

Name and Office

The name of the corporation shall be Presley Adjusting Services, Inc., and the corporate address shall be 2170 W. State Rd 434, Suite 250, Longwood, FL 32779.

ARTICLE II

Duration

The duration of the corporation is perpetual.

ARTICLE III

General Purposes

The purpose of the corporation is to engage in any acts or activities for which a corporation may be organized under Chapter 607 of the Florida Statutes.

ARTICLE IV

Shares

The aggregate number of shares which the corporation shall have authority to issue is One Hundred Thousand (100,000) shares of Class A voting common stock, \$.01 par value per share, and One Hundred Thousand (100,000) shares of Class B nonvoting common stock, \$.01 par value per share. The preferences, limitations and relative rights of Class A stock and Class B stock shall be identical in all respects, except that each share of Class A stock shall be entitled to one vote, and that each share of Class B stock shall have no voting rights.

ARTICLE V

Initial Registered Office and Agent

The address of the initial Registered Office of the corporation is 2170 W. State Rd 434, Suite 250, Longwood, FL 32779, and the initial Registered Agent at such address is Helen Presley.

Initial Board of Directors

The number of Directors constituting the initial Board of Directors of the corporation is three (3). The number of Directors may be increased or decreased from time to time, but in no event shall the number of Directors be less than one (1). 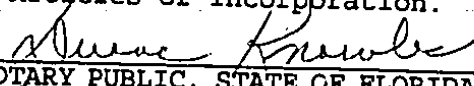

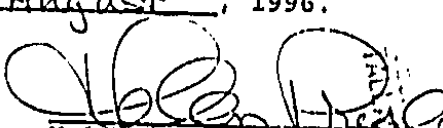
