ARTICLE 1. - NAME

The name of the corporation is PUBCO, INC.

ARTICLE 2. - PRINCIPAL OFFICE

directors or arising out of their status as such.

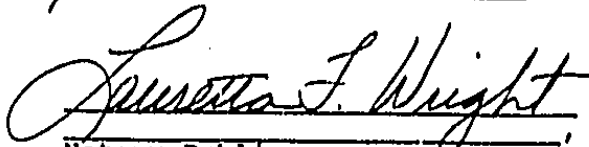
