ON THE TARY OF STATE OF STATE

OF

CAREMED MEDICAL GROUP OF HALLANDALE, INC.

ARTICLE I NAME

The name of the corporation is Caremed Medical Group of Hallandale, Inc. (hereinafter called the "Corporation").

ARTICLE II - PURPOSE

The Corporation is organized for the purpose of transacting any or all lawful business for corporations organized under The Florida Business Corporation Act of the State of Florida.
