ARTICLE I - NAME AND ADDRESS

The name and mailing address of the Corporation is Prince & Cooke Corp. and c/o Julio E. Manguart, 1428 Brickell Avenue, Main Floor, Miami, FL 33131, respectively.

ARTICLE II - DURATION

The Corporation shall have a perpetual existence.

ARTICLE III - PURPOSE

The purpose of this Corporation is to engage in any activities or business permitted under the Laws of the United States and Florida.
