ARTICLES OF INCORPORATION

OF

HEAVY EQUIPMENTS INC.

ARTICLE I- NAME

The name of the corporation is HEAVY EQUIPMENTS INC .

ARTICLE II - DURATION

This Corporation shall have perpetual existence.

ARTICLE III - PURPOSE

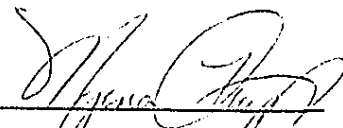
