ARTICLES OF INCORPORATION
OF
J-MARC COMMUNICATIONS, INC.

The undersigned incorporator makes, subscribes, acknowledges and files with the Department of State of the State of Florida these Articles of Incorporation for the purpose of incorporation under the laws of the State of Florida.

ARTICLE ONE

The name of the corporation is J-Marc Communications, Inc.

ARTICLE TWO

The period of its duration is perpetual.

ARTICLE THREE

The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Florida Corporation Act. The specific nature of business for which the corporation is organized is to provide communication services.

ARTICLE FOUR

The aggregate number of shares which the corporation shall have authority to issue is 100 of the par value of One Dollar (\$1.00) each.

ARTICLE FIVE
