We, the undersigned, hereby associate ourselves together for the purpose of becoming a corporation under the laws of the State of Florida providing for the formation, liabilities, rights, privileges and immunities of a corporation for profit pursuant to the following Articles of Incorporation.

**Article I: Name**

The name of the corporation shall be At Your Service Pet Sitting Inc.

**Article II: Principal Place of Business**

The principal place of business of said corporation shall be in Tallahassee, Leon County, Florida, with the privileges of having branch offices at other places within the State of Florida and within or without the United States of America. **Article III: General Nature of Business**

This corporation may transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.
