In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

Article I

The name of the corporation ("Corporation") is **AUTO SAVE OF ORANGE PARK, INC.**

Article II

The street address of the principal office of the Corporation is 4380 EII Whitney Drive, Middleberg, FL 32068.

The maximum number of shares this Corporation is authorized to issue is 500 all of which shall be Common Shares.
