Gentlemen:

Enclosed you will find my check in the amount of \$150.00 dated August 27, 2001 for the 2001 Uniform Business Report.

I contacted your office via telephone to explain to you why I had not previously paid this fee before the May deadline. I was instructed to send the \$150.00 check with this letter explaining my reason.

This corporation is a home-based business that has very little activity...the remnants of a business that was once selling copiers, faxes, etc. There are no current sales and there have not been in years. Because we continue to owe money on loans taken out when the business was doing business, we must keep the corporation open.

There are several reasons why I did not send the \$150.00 fee by May. I appreciate your taking the time to review these reasons.

In February, through a CT Scan doctors found a mass in the center of my chest. I was terribly distraught and was going from doctor to doctor, state to state trying to find out what to do. I was told that they could only remove it by sawing through the breastbone. On the advice of one doctor, I continued to seek out a doctor that could remove it without doing that. My husband and I were consumed with this medical problem. I was so overwhelmed that I was barely functioning. At the same time, I was being diagnosed with either lupus or rheumatoid arthritis. We were not taking care of paperwork. Health was really the only thing of our minds.

I was scheduled for surgery on May 10. The mass was removed and thankfully not cancer. However, the physician had collapsed my lung and removed the tumor through the ribcage. I had numerous complications after the surgery and was literally in bed for another eight weeks on pain medications and steroids.

During my health crisis and as April 15 was approaching, we called the accountant who had always taken care of our taxes to tell her that we were not going to be able to get all of our tax information together. She was the person who had stayed on top of this filing fee in the previous years. We were told on that day that she was no longer with the accounting firm (Saltmarsh, Cleveland and Gund) and were directed to Steve Huggins, the shareholder in charge of our account. He advised that he would file an extension and for us to just take care of my health. Then, on April 21, Steve Huggins was killed in a terrible accident.

Through the combination of my health problems, our long-time accountant leaving the firm and the untimely death of Steve Huggins, the filing fee was not taken care of.

I had always put anything to do with the corporation in a file for the accountant and she would take care of everything at tax time. Since we did not file our taxes before April 15, the accountant had not looked in the file and the UBR filing fee was overlooked.

Subsequently, in order to file our taxes before the September deadline, we tracked down the original accountant. She is the only person familiar with our taxes. She is working for a concrete block company now. We asked her if she would come and go through all of our tax information to get it ready to be filed. Our corporate and personal taxes were always filed together. She came last Saturday, August 25, on her day off strictly as a favor to us. She was aware that because of Steve's death and no one else in the firm being aware of our circumstances, we really needed her. It was at that time that she pointed out that we had not sent in our UBR filing fee.

I would like to respectfully request that you accept the \$150.00 as payment for the filing fee. This was not a normal year for us; and, the fee being late was an oversight resulting from all of the circumstances described above.

I appreciate your consideration and wait to hear from you.
