The undersigned, acting as incorporator of a corporation under the Florida General Service Corporation Act, adopted the following articles of incorporation for such corporation:

ARTICLE I. NAME: The name of the corporation is: VOLUSIA INDEPENDENT PHLEBOTOMIST SERVICES, INC. Principal office: 427 S.#195 Nova Road, Ormond Beach, Fl. 32174

ARTICLE II. TERM OF EXISTENCE: The period of its duration is perpetual.

ARTICLE III. PURPOSE: The general purposes for which the corporation is organized are the following:
