The undereigned, for the purpose of forming a corporation under the Florida General Corporation Act; to hereby adopt the following Articles of Incorporation: 96 AUG 28 AH 8: 32

ARTICLE ONE

SEGRI PART OF STATE TALLAHASSEF FLORIDA The name of the corporation is AT YOUR SERVICE OF PALM BEACH COUNTY INC.

ARTICLE TWO

The duration of the corporation is perpetual. The date and time of the commencement of corporate existence is September 1, 1998,

ARTICLE THREE

EFFECTIVE DATE 9-1-96
