The undersigned natural person, of legal age, acting as Incorporator under the provisions of Chapter 607, Florida Statutes, adopts the following Articles of Incorporation:

**ARTICLE I
Name of Corporation**

The name of this Corporation shall be Dream Homes, Inc.

**ARTICLE II
Principal Office of Corporation**

The principal office address of this Corporation shall be 5376 Appledore Lane, Tallahassee, Florida 32308, and its principal mailing address shall be Post Office Box 15335, Tallahassee, Florida 32317.

**ARTICLE III
Stock Clause/Shares**

The aggregate number of shares of stock which this Corporation shall have authority to issue shall be Ten Thousand (10,000) shares of voting common stock and Ten Thousand (10,000) shares of non-voting common stock, all of one class at One and No/100 Dollars (\$1.00) par value per share.

The date that corporate existence shall begin shall be upon filing by the Secretary of State. This election is pursuant to Section 607.0123, Florida Statutes.

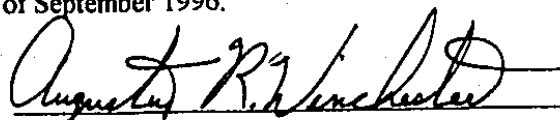
ARTICLE X

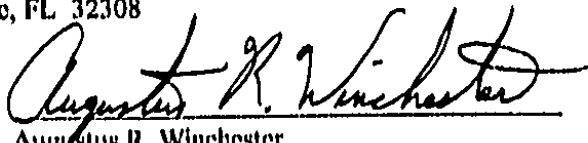

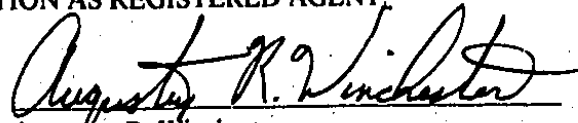
